The applicant seeks the following special use amendment and development standards variance approvals:

3. Docket No. PZ-2023-00008 V UDO Section 2.10 Maximum 35-ft building height for principal building and 18-ft height for accessory buildings allowed, 38'3" and 28'6" requested.

4. Docket No. PZ-2023-00009 V UDO Section 2.10 & 5.02.B Minimum 30-ft building setback from Keystone Pkwy allowed, 19'4" requested.

5. Docket No. PZ-2023-00010 V UDO Section 3.28 Minimum 30-ft wide greenbelt required along Keystone Pkwy, 19'4" requested.
